EPA estimates that the heat input capacity for these boilers is typically between 10 and 250 MMBtu/hr. However, larger industrial boilers do exist and are similar to utility boilers. Commercial/Institutional boilers are generally smaller than the industrial units with heat input capacities generally below 10 MMBtu/hr.
