The following is a defense of our forebears gleaned, not from the biased writings of their enemies, but from their own writings. Most of the names used to identify these early Christians were given to them by their detractors in an attempt to identify them with men, rather than with the Lord Jesus Christ.

IN DEFENSE OF BIBLICAL, HISTORICAL CHRISTIANITY

In the 2nd century, several Christian writers—Aristides, Justin Martyr, Tatian, Theophilus, Athenagoras, Tertullian—defended Christianity against the popular and political charges brought against it by non-Christians. It was denounced as an unregistered and “secret” cult and was suspected of immorality (human flesh and blood were consumed at its love feasts) and disloyalty (Christians refused to participate in the civic religion).

The First Apology was an early work of Christian apologetics addressed by Justin Martyr to the Roman Emperor Antoninus Pius. In addition to arguing against the persecution of individuals solely for being Christian, Justin also provides the Emperor with a defense of the philosophy of Christianity and a detailed explanation of contemporary Christian practices and rituals. This work, along with the Second Apology, has been cited as one of the earliest examples of Christian apology, and many scholar

Tertullian was born in Carthage (modern Tunis) at about the time of Polycarp's death and probably trained as a lawyer. He converted from his pagan background and devoted himself to writing impassioned books — more than 30 in total — in defense of the true faith.
