The Rhode Island Lemon Law

A lemon is considered any recently purchased vehicle, new or used, with an unexpected flaw that is not repaired after repeated attempts by the seller or manufacturer within a reasonable period of time. To protect you from such a problem, Rhode Island instituted a lemon law . Basically, the Rhode Island lemon law requires vehicle manufacturers to either replace your vehicle or refund your purchase if your vehicle is determined to be a lemon.

The Rhode Island lemon law covers vehicles with major non-conformity defects. Owners of newly purchased vehicles may file for a claim under the state’s law if the manufacturer is unable to resolve the issue. Time limits and deadlines apply. Not all vehicles qualify for benefits and not all defects are eligible for a claim.

Rhode Island Lemon Law at a Glance. According to Rhode Island statute, the state’s lemon law protects car buyers for up to one year from delivery or 15,000 miles, whichever comes first. Eligible consumers invoking the lemon law may choose either a comparable replacement vehicle or a full refund (minus a "reasonable allowance" for use).

This law covers new and leased automobiles, motorcycles, vans, and trucks that weigh less than 10,000 pounds. These vehicles must have been sold or replaced in the state of Rhode Island in order to be covered. The law does not cover motorized campers.

The federal lemon law typically provides a longer time frame to pursue a lemon law claim and is generally 4 years from the date that the manufacturer “breached” or failed to honor its promise to repair your vehicle.
